
prijedor means







- Company "Lipa-drvo" set up in 2000, it is a sawmill with a modern line of sawing machinery, including steaming, drying chamber and finalization processing
- High quality standard of products and also the assurance of constant product availability for all customers
- Main products semi-trimmed and trimmed planks, fresh, seasoned and dried, white and steamed, production of semi-finished products for wood industry (chairs, living-room furniture, etc.)





case study in metal processing sector...





- Company "Metal Industry Prijedor" MIP with more than 50 years of work experience achieved remarkable success in all production areas of metal constructions
- Cooperation with highly demanding partners from Germany, Austria, Italy, France, Russia, Slovenia, Netherlands, Spain, Libya, Algeria, etc.


